

Even if you're vigilant about avoiding animal collisions, the risk of hitting a deer with your vehicle heightens in the late fall and early winter.

State Farm® estimates that 1.35 million auto-deer collisions occurred in the U.S. between July 1, 2016 and June 30, 2017.

These crashes were costly for drivers, with a national cost per claim average of \$4,179.

If you're involved in an auto-deer collision, here's what to do:

- Move your vehicle to a safe place. If possible, pull over to the side of the road, and turn on your hazard lights. If you must leave your vehicle, stay off the road and out of the way of any oncoming vehicles. Deer are most active at dusk and dawn. These are times when you or your vehicle may also be less visible to other motorists.
- 2. **Call the police.** Alert the authorities if the deer is blocking traffic and creating a threat for other drivers. If the collision results in injury or property damage, you may need to fill out an official report. This report also can prove useful when filing your insurance claim.
- 3. **Document the incident.** If it's safe to do so, take photographs of the roadway, your surroundings, damage to your vehicle, and any injuries you or

- your passengers sustained. If there are any witnesses that stop, take down their account of what occurred, and ask for their contact information.
- 4. **Stay away from the animal.** A frightened, wounded deer could use its powerful legs and sharp hooves to harm you.
- 5. **Contact your Insurance agent.** The sooner you report damage or injuries, the sooner your agent can file and process your claim. You can usually report a claim online at your insurance company website, by calling their 1-800 number, or through a mobile app.
- 6. **Don't assume your vehicle is safe to drive.** Always double-check that your car is drivable after colliding with a deer. Look for any leaking fluid, loose parts, tire damage, broken lights, a hood that won't latch and other safety hazards. If your vehicle seems unsafe in any way, call for a tow so that the situation does not get worse.

Before a collision occurs, make sure you're protected with the right type of insurance. Damages from auto-deer crashes are typically covered under comprehensive insurance, not collision. Contact your insurance agent to learn more and make sure that you will be covered.

Great news! The DMC FunRun has again exceeded the expectations of the planning team! This year, we reserved a hotel with 35 rooms for night 1 (10 more rooms than last year). We are currently at 33 room reservations for night 1 (September 8). **The last 2 rooms are available on a first-come first-serve basis.**

For night 2, our dinner venue can only accommodate 65 people. We are already at 56. The remaining nine dinner spots will be available on a first-come first-serve basis, for night 2 (September 9).

This momentum, again, confirms that DMC is a fun group that enjoys a great time! Thanks to all who have already RSVP'd.

Next Steps:

- 1. **Read over the RSVP list below.** Make sure we have your details correct (# nights, # people). If you previously signed up, but are unable to come, please let us know asap so we can open up your spot for someone else. If you want to be on the list, reply ASAP with your RSVP details.
- 2. To secure your room reservation, please make a non-refundable, \$100 deposit (per room), as soon as possible. If you'd like to pay that with credit card, we can accept credit card payments at the club meeting this Friday. Receipts will be issued, electronically via email, for your records. The deposits are needed so that DMC can lock-in on the hotel space. The deadline for the current list of folks on the RSVP list to make this deposit is March 20. On March 20, we will open up space for others who have expressed an interest. If you have special circumstances, please let us know.
- 3. Watch for details on final payment information. The planning team will finalize trip details and will set a date for final payment, likely in June. At that time, you can pay your balance and your RSVP will be set.
